## Terms and Conditions

- 1. General Terms: This Agreement shall be governed by and construed following the laws of the State of Connecticut. Connecticut State Law requires Santa Energy (For the remainder of this agreement, Santa Energy refers to Santa Energy, Servco Oil, and Branchville Oil) to purchase futures oil contracts to make this contract. The Customer agrees to provide safe and unobstructed access to an oil tank that meets applicable fire and safety codes.
- 2. Plan Definitions: This is a CAPPED Price Plan: The per-gallon fuel price under a cap contract will "NOT EXCEED" the Price Cap during the Plan program dates. There is a fee associated with the CAPPED Price Plan. Your delivery ticket will always show your price on your delivery date. If taxes are levied against home heating fuel during this Plan, the Customer shall pay those taxes to Santa Energy.
- 3. **Gallons:** This Plan covers a customer's estimated annual volume. Estimated gallons are based on the home's square footage and what a customer would reasonably expect to use for a family's heat and hot water. The maximum number of gallons covered by this Plan is 2,000 gallons unless stated at 500 gallons or 800 gallons plans.
- 4. Automatic Delivery: The Customer agrees that Santa Energy is the sole supplier of heating oil and agrees to accept deliveries on an automatic delivery basis. After the Price Plan period expires or gallons per agreement (500, 800, 2000) are used, the Customer

**agrees to remain on automatic delivery with Santa Energy at Santa's Daily Posted Price.** The Customer can terminate automatic delivery after the Plan period by providing Santa Energy with a written request. The written request may be by postal letter or email.

- 5. **Plan Dates:** This Plan is effective upon Santa Energy's acceptance of the Customer's signed agreement. The Plan expires on April 30, 2025. Deliveries made after April 30, 2025, will be charged at Santa's Daily Price.
- 6. Acceptance: This Plan is time-sensitive, and Santa Energy reserves the right not to accept a Plan not returned within three (3) days. This price becomes effective when Santa Energy receives your signed Price Plan and Cap Fee payment. Your account balance must be current and in good credit standing. If your account becomes past due at any time, Santa Energy reserves the right to place your account on a C.O.D. basis and charge Santa's Daily Price per gallon for deliveries made while the account is past due.
- 7. **Cancellation:** If you cancel this Plan before the Plan END DATE, the Customer agrees to forfeit the Cap Price Program fee. All cancellations must be in writing by postal letter or email.
- 8. Liability: In the event of war, terrorism, national crisis, circumstances beyond our control, or the non-ability of Santa Energy suppliers to provide price-protected fuel to Santa Energy, Santa Energy may cancel this Plan.

## Please Acknowledge

I have read and accepted the terms and conditions of this Price Plan.

I acknowledged a fee associated with the CAPPED Price Plan and agree to pay that fee. Failure to pay that fee will terminate this agreement.

I understand that my plan price will expire on April 30, 2025. I know that if I go over my gallon limit (500, 800, or 2000) before April 30th, 2025, I will be reverted to the daily floating price.
